The “forecast” also enables the government customer along with the government procurement team to work in tandem to conduct market research prior to the solicitation being advertised. The “forecast” and the published contents are provided in accordance with Public Law 100-656, Section 501 of the Business Opportunity Development Reform Act as amended, requires in part all federal agencies to prepare an annual forecast for public viewing. It’s important that as we continue to work towards publishing our evolving forecast, the government actively participates in advanced acquisition planning efforts. Based on our research, the published “forecast” when made available via the internet is a win for the “triple

helix” of government, industry and academia. ### **ANALYSIS: FISCAL YEAR-END 2009 USAMRMC & FORT DETRICK SMALL BUSINESS ACHIEVEMENTS.**

Source: Federal Procurement Data Systems -  
Next Generation (10/14/2009). An abbreviated  
analysis reveals:

During FY 2009, there were approximately  
7,226 contract actions of which 3,749 were  
awarded to U.S. Small Business Firms. This  
represents **52%** of all contract actions. In  
terms of dollar amounts, our records show  
**\$573M** was awarded to small business firms  
in comparison to **\$524M** during the previous  
fiscal year.

In comparison to the previous Fiscal year, there  
was a **9.4% increase** of awards to small  
business firms and **63% increase** of awards  
to Small Disadvantaged and SBA 8(a) firms  
for Fiscal Year 2009.

Women Owned Small Business firms were  
awarded **\$97M** in contract awards in com-  
parison to **\$92M** during the previous Fiscal  
Year.

There were 531 Veteran Owned Small Business  
contract actions for Fiscal year 2009 in the  
amount of **\$67M**. There have been 254 Ser-  
vice Disabled Veteran Owned Small Busi-  
ness contract actions during Fiscal year 2009  
in the amount of **\$28 M**, versus \$18M during  
Fiscal Year 2008.
